While applying for JKSSB Female Supervisor 2024, you must submit the required documents as mentioned in the application form. - · Aadhaar Card/Printout of E-Aadhaar
- · Voter's ID Card
- Driving License
- PAN Card

JKSSB Female Supervisor 2024 - Application Fees

Those of you applying for the Female Supervisor position in the Social Welfare Department of Jammu and Kashmir must submit an application fee according to their respective categories. If you are someone falling under categories like OM/RBA/ALC/IB/OSC/PSP/ESM are required to pay an application fee of **Rs. 500**. On the other hand, if you are someone falling under EWS/SC/ST/PwD categories, you will have to pay a reduced fee of **Rs 400**.

JKSSB Female Supervisor 2024 - Eligibility Criteria

- **Nationality:** You must be a citizen of the union territory of Jammu and Kashmir. Moreover, you must possess a valid certificate of domicile.
- **Education:** You must posses a bachelors' degree or equivalent as on the cut off date fixed for filling the online application forms.
- Age Limit: You must not be below 18 years of age and not above 43 years of age as on 01.01.23.
