



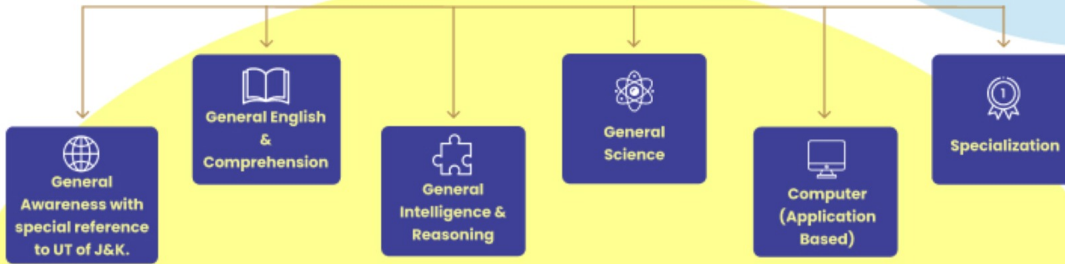

- **Age Limit:** The eligibility criteria regarding age for applicants aiming to secure the position stipulate that individuals should fall within the age bracket of 18 to 40 years as on 01.01.2023.
