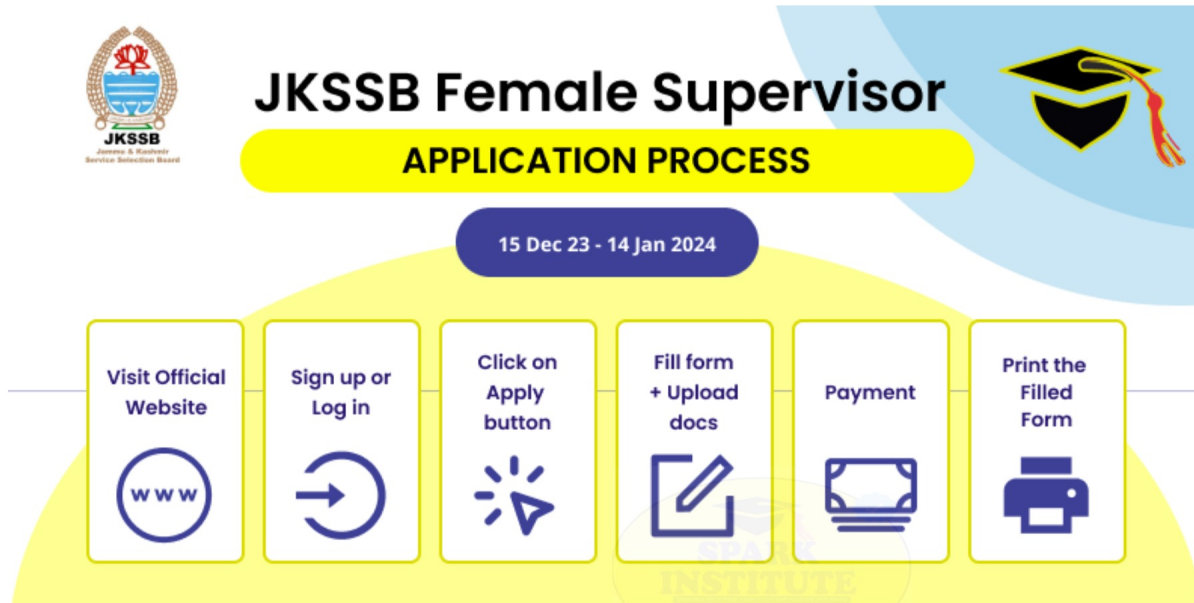
## JKSSB Female Supervisor Application Process 2024

## JKSSB Female Supervisor 2024 - Application Fee

Candidates applying for the Supervisor position in the Social Welfare Department of Jammu and Kashmir are required to submit an application fee based on their respective categories.

- Those in categories such as OM/RBA/ALC/IB/OSC/PSP/ESM have an application fee of Rs 500.
- While candidates in the EWS/SC/ST/PwD categories will pay a reduced fee of Rs 400.

The payment process is designed to be user-friendly, offering candidates multiple options such as debit card, credit card, NET banking, or UPI.

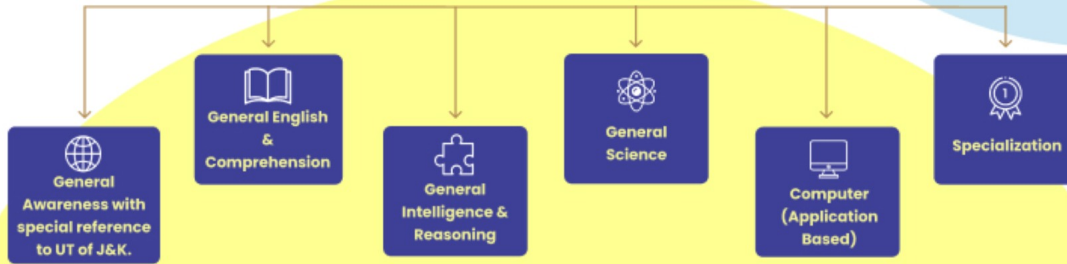
